Introduction

Community-Based Child Abuse Prevention (CBCAP) Lead Agencies are expected to promote the development of a continuum of prevention services through State and community-based collaborations and public-private partnerships. The Directory has been created as a resource to all CBCAP lead agencies in the development of their continuum of services. It is not intended to be exhaustive of all programs with which CBCAP should be collaborating.

Over the last few years, CBCAP Lead Agencies have also been encouraged to collaborate with the child welfare programs and specifically the Promoting Safe and Stable Families programs in their States. Both CBCAP and PSSF address common issues around prevention and family support and in many States, these programs are funding similar efforts. Because of the importance of linking these efforts in the State, the primary contacts for the PSSF programs are also included in this Directory.

These National Organizations were identified because of their demonstrated leadership within the field of child abuse prevention.
