## Colorado

**Core Services:** In FFY2017, CBCAP funding supported direct services in communities through two evidence based parenting programs: The Incredible Years and Parents as Teachers. Colorado is highly invested in both programs and utilizes many funding streams to implement them broadly across the state. In partnership with Invest in Kids (IIK), CBCAP supported the implementation of the Incredible Years Program (IY) with seven community agency partners serving a six county area. This investment allowed Invest in Kids to provide site selection, training, coaching, evaluation and fidelity monitoring supports to these communities. IIK supported the high-quality implementation of the IY Parent Program with each of the seven community agencies, delivered through 14 weekly parent group meetings. CBCAP also partially funded the Parents as Teachers (PAT) program, in partnership with the Colorado MIECHV program, to implement programming through four community agencies.

Other CBCAP funded awareness, workforce development and systems building activities include:

- The OEC collaborated with Illuminate Colorado, the Colorado Chapter of Prevent Child Abuse America, to expand Pinwheels for Prevention programming and deepen partnerships for Child Abuse Prevention Month in April 2017.
- In April 2017, Governor Hickenlooper launched the Colorado Child Maltreatment Prevention Framework for Action to set state priorities and guide local communities in creating focused and integrated plans to prevent child maltreatment and promote child well-being.
- The Denver Indian Family Resource Center (DIFRC) makes a point to adjust and adapt its services to be relevant to tribal cultures. This year, DIFRC was contracted to provide outreach and coordinated case management to American Indian/Alaska Native families. They also facilitated a monthly meeting with a network of providers serving the AI/AN population to increase cultural competency and efficacy.
- During this grant year, CBCAP funds were used to conduct a needs assessment describing the experiences and needs of veteran parents and their partners in Colorado. The topics included in the analysis were broadly related to the experience of parenting as a veteran or the partner of a veteran.
- CBCAP funded a pilot project implementing Circle of Parents, an evidence informed parent support group model, for parents in substance use recovery in four family resource centers.
- In 2017, CBCAP provided support to the Early Childhood Colorado Partnership (ECCP) which has developed a shared messaging bank around preventing and mitigating toxic stress in early childhood. The funds supported the training of messaging mentors that could help interested early childhood organizations integrate these messages into their communications. In addition, the ECCP made revisions to the shared messaging bank online platform to increase usability and developed an evaluation plan for the shared messaging work.

During the year we exercised that role by continuing to build on our three main initiatives of child sexual abuse prevention (Stewards of Children), Strengthening Families<sup>™</sup> integration through training and strategic funding, and Hope Conquers ACEs, a statewide training initiative on the power of positive experiences in mitigating the effects of trauma and Adverse Childhood Experiences as well as preventing child maltreatment from occurring in the first place. Funded programs served Latino, refugee, low-income and rural families within the context of those initiatives.

The FSPS also coordinates the Home Visitation Leadership Advisory Coalition (HVLAC) created in 2002 and continuing today in an effort to bring all Oklahoma home visitation programs together to collaborate by sharing information, working collectively on projects and hosting guest speakers relevant and critical to the field.



Home visitation: CBCAP provides support for the Parents As Teachers Program and the Nurse-Family Partnership Program (referred to as Children First locally).

The Incredible Years, COP and PCIT were part of the services offered with CBCAP funding through the Child Guidance Service at OSDH often working jointly with the FSPS as they did during FFY 2016.

Trainings for professionals and others: Required NFP and PAT training were provided. In addition, CBCAP funds were used to support statewide conferences and coalitions.

Child abuse prevention awareness: The FSPS facilitates the running of specific prevention commercials every April on various stations throughout the state;

The OSDH/FSPS partners with Moroch Advertising on McDonald tray liners in celebration of "National Family Month" for two weeks every June to promote components of child abuse prevention (at no cost - there are typically over half a million tray liners utilized in almost 200 locations with a prevention message crafted by FSPS that changes yearly; and

The FSPS created and distributed new English and Spanish Hotline Reporting Cards statewide – both electronic and hard copies of the fold over card were made available. Not only does the card provide the definition of Oklahoma's mandated reporting law and the correct procedures for reporting suspected or known abuse, it also talks about "supporting parents in public" with a few examples.

The FSPS also created and coordinates the Child Abuse Prevention (CAP) Action Committee, which is a large collaborative group of individuals from several different programs, agencies, universities, the private sector and more, working together to steer primary prevention projects including activities and campaigns for April, National Child Abuse Prevention Month.
