#### **CBCAP Grant Coordinator Position**

- Supplemental funding will cover salary/fringe through 2025.



# CBCAP Grant Coordinator Roles and Responsibilities

#### **About the Job:**

The Community Based Child Abuse Prevention Coordinator develops and coordinates the programmatic aspects of the Community Based Child Abuse Prevention Program (CBCAP) for the Indiana Department of Child Services, Prevention Services Team of the Child Welfare Services Division.

This position is funded by the Community Based Child Abuse Prevention (CBCAP) Grant and is contingent on ongoing funding availability.

## **Community Partners for Child Safety (CPCS) Indiana**

- History
  - Started in Marion County Co-Located with Child Welfare Agency
- Served 23,245 adults and 25,292 children for a total of 48,537 individuals
- In all 92 counties in Indiana
- Started in 2006
- Have 5 providers
- Referrals received from: Schools, DCS, self, etc.



 Goal #1: Prevent families from entering the DCS child abuse and neglect system by improving family functioning.

 Goal #2: Ensure family and community satisfaction with services.



#### **Services Offered**

- CPCS provides in home visitation. Staff help families develop family-centered goals & connect them with local community services.
- CPCS provides service coordination, information and referrals, in-home case management, and advocacy for the family.
- The top needs identified in FFY 2021 were rent/utilities, counseling, help with child behavior, subsidized housing, and info on budgeting.

# Indiana's Framework for the Prevention of Child Abuse and Neglect

- 2018: The Child Abuse Prevention Sub-Committee of the Commission on Improving the Status of Children identified the need for a statewide child abuse prevention framework.
- 2019: The Commission voted to approve the recommendation. The Indiana Department of Child Services (DCS) agreed to fund the development of the framework and this accompanying toolkit.
- 2019-2022: Create Statewide Advisory Team, conducted research and analysis, and created Indiana's Framework for Prevention of Child Abuse and Neglect.



## Process for Framework Development



Convene Statewide Advisory Team.

Create an initial draft of the framework and toolkit with input from the Statewide Advisory Team.

Identify pilot
communities and key
local stakeholders
(parents, child welfare
professionals, other
community
agencies, etc.) to
solicit feedback on the
draft framework and
toolkit.

Host planning retreat with the Statewide Advisory Team to review feedback from the pilot communities and identify changes to be made to the framework and toolkit. Make edits to and finalize the strategic framework and toolkit.

Disseminate the framework and toolkit statewide.



## Purpose and Goals of Framework

The purpose of Indiana's Supportive Communities, Resilient Families, Thriving Children framework is to create a statewide approach to achieve the vision that:

All children thrive in safe, stable, nurturing, and supportive families and communities that foster resilience and well-being.

#### Goals:

Increase the effectiveness, alignment, and coordination of existing child maltreatment prevention efforts

Identify new opportunities to support the resilience and wellbeing of vulnerable children and families to decrease the incidence of child maltreatment in Indiana



#### INCENTIVIZING CONTINUOUS QUALITY IMPROVEMENT AND INNOVATION





#### Summer 2021 ⇒ Prioritizing

Hi Mary Beth,

Do you have some time in the next couple weeks to meet and let me pick your brain? Here is some context of what I am looking to do:

The federal program that I run for Utah (<u>CBCAP - Community-Based Child Abuse Prevention</u>) is receiving a a large chunk of emergency one-time use dollars as part of the most recent federal COVID relief package. The program is also anticipating increases in ongoing funding as part of the Strong CAPTA Bill that is working its way through Congress right now. We would like to make steps toward using this money in a more meaningful, data-driven way than we have in the past.

We have been discussing the importance of having community-based needs assessment to guide our programming decisions. I know that the Dept of Health's MIECHV program partners with the U's Division of Public Health to do something like this every few years using their MIECHV funding. Sometime like that is my grand vision, but I also don't know if we have time to realistically do something like that since this is one-time funding that must be allocated quickly.

I have been collecting outside data sources and reports for the past year. Part of me believes that all the info I need is probably out there somewhere and I just need help making sense of it all. I am curious if this is the type of thing that SRI can help with, and if so, what sort of cost and time frames we're talking about so I know what's realistic to plan for with this one-time funding.
