Annual CBCAP Grantee Meeting

From the 2018 CBCAP Program Instruction:

The budget must allocate sufficient funds to provide for at least one representative from the state to attend an annual 2-5 day federally initiated CBCAP grantees conference. Attendance at this meeting is a grant requirement.

2019 CBCAP Grantee Meeting

- The purpose of this annual meeting is to share Children's Bureau updates and priorities, monitor grantee progress, foster peer learning, and support knowledge development and transfer.
- This will occur through plenary presentations, breakout sessions, grantee poster exhibits and peer sharing.

2019 Meeting Objectives include:

- Gain information on specific topics and strategies to support effective implementation and maintenance of their CBCAP programs and guidance on how to apply them in their states and jurisdictions.
- Network with peers, parent leaders, Federal Project Officers and technical assistance providers to learn about resources and strategies to address challenges and enhance their CBCAP programs.

April 23-24 – Additional Activities

State Team Planning Meeting

- The purpose of the meeting is to help state teams continue to craft the 5-year Child and Family Service Plans (CFSPs) that serve as road maps for implementing a joint vision for child welfare.
- Teams should include <u>one representative</u> from the state's CBCAP lead agency along with CIP staff and legal and judicial representatives, and Child Welfare Agency Leadership.



Offers a financial empowerment toolkit developed by the Consumer Financial Protection Bureau. The curriculum empowers parents by strengthening their ability to manage money, use financial services, and provide access to products that work for them.











Colorado Office of Early Childhood

Colorado Community Response Program

Provides a voluntary prevention program that includes case management, family goal setting, financial education, one-time financial assistance, and resource referrals for families who have a "screened out" referral or closed high-risk or family assessment.









Concrete Support

Kansas Children's Cabinet and Trust Fund

Response Advocate Program

Response advocates work alongside law enforcement to assist at-risk families with concrete supports, such as home visiting, goal-setting assistance, education on child development, and referrals to community resources.


