Application Timeframes



*All obligated Federal funds awarded under this grant must be liquidated no later than 120 days after the end of the funding/obligation period (1/28/2027). Any federal funds from this award not liquidated by this date will be recouped by this Department. Availability of Funds

As of March 23, 2024, the Further Consolidated Appropriations Act, 2024 (H.R. 2882) made available **\$70,660,000** for the CBCAP program in FY2024.

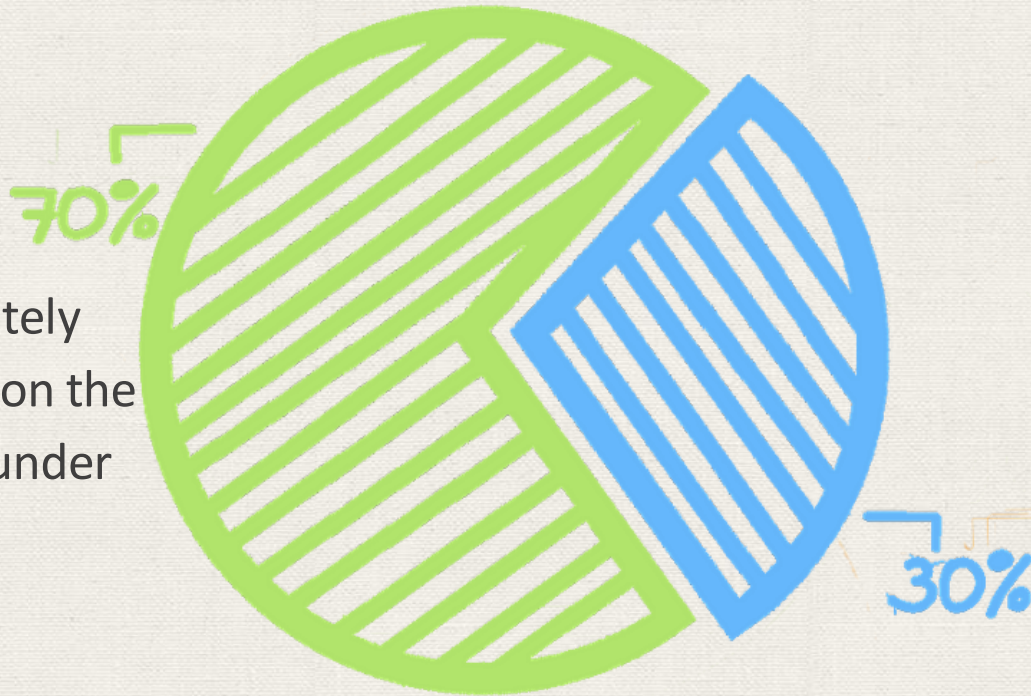
A certain amount must be set aside for specific legislative purposes, including:

- (1) one percent of the total appropriation “to make allotments to Indian Tribes and Tribal organizations and migrant programs” (Section 203(a));
- (2) continued funding for a National Center for CBCAP; and
- (3) continued funding for program support.

Distribution of Funds

Section 203(b)(1) provides that the funds available for distribution to the states under the CBCAP program will be allotted as follows:

Allotted proportionately among states based on the number of children under age 18.



Allotted proportionately among states based on the amount of funds leveraged.

Budget

- Format budget to clearly display line-item expenditures for both Federal and non-federal funds
- Must include 20% Cash Match (state or private funds)
 - Determined based on the population-only (70%) portion of the formula.
 - Within 30 days of receipt of the Grant Award Letter, the lead agency must submit an amended budget to reflect a 20 percent match of the full amount of the grant award
- Must include funds for at least one staff member to attend a 2-5-day Federal Mandatory CBCAP Grantees Meeting

*No longer limited to less than 20% of administrative costs.

**ATTACHMENT 2:
Tentative Population Allocation of CBCAP Funds – FY 2023**

IMPORTANT NOTE: The following figures represent our best estimate of what each state, Puerto Rico, and the District of Columbia will receive for the population portion of their grant award allocation. These figures are based on a 70 percent formula figure, census figures available, and an assumption that each of the Territories will receive the base amount of \$175,000. These figures could change if census figures are updated, if there are additional set-asides in the appropriation, or if state participation differs from what is predicted at this time. The amount of funds available and population fluctuations have impacted the population distribution amounts for most of the states over last year's estimated allocation.

For purposes of submitting the application, each state may use this amount when calculating its budget and determining the 20 percent matching funds obligation as set forth in section III-G-1 of the PI. Since this amount is only tentative, each state must submit a revised budget to OCAN (at CBCAP@acf.hhs.gov) to complete the application, no later than October 31, 2023. The revised budget must be based on the actual amount awarded to the state, as verified in the Grant Award letter. For those States providing matching funds in excess of 20 percent, if the excess amount meets the 20 percent requirement of the final grant award, such states do not need to submit budget amendments.

Leveraged Claim Form

- In order for a State to document funds claimed as leveraged funds, the application must contain a completed copy of the Leveraged Funds Worksheet, which includes:
 - an itemization of the funds being claimed; and
 - an assurance statement that is to be signed by the responsible lead agency administrator and fiscal authority for the lead agency verifying the authenticity of the submitted claim

Leveraged Claim Form (cont.)

- Funds claimed as leveraged funds may include any funds that were:
 1. Leveraged by the state from private, state, or other non-federal sources during FFY2022 (October 1, 2021 – September 30, 2022)
 2. Directed through the CBCAP lead agency for FFY2022; and
 3. Budgeted and spent during FY2022 for use in supporting community-based child abuse and neglect prevention programs and activities

Use of CBCAP Funds

Primary Prevention

Universal programs and strategies that are available to all families.



Secondary Prevention

Targeted prevention efforts that target children and families at risk for abuse or neglect.

Use of CBCAP Funds

- offer assistance to families;
- provide early, comprehensive support for parents;
- promote the development of parenting skills, especially in young parents and parents with very young children;
- increase family stability;
- improve family access to other formal and informal resources and opportunities for assistance available within communities, especially for unaccompanied homeless youth;
- support the additional needs of families with children with disabilities through respite care and other services;
- demonstrate a commitment to involving parents in the planning and program implementation, including meaningful involvement of parents of children with disabilities, parents with disabilities, racial and ethnic minorities, and members of underrepresented and underserved groups; and
- provide referrals to early health and developmental services.

* The DUNS number is being replaced by a Unique Entity ID (UEI) effective 4/2/22. All existing grantees can check the government website SAM.gov to retrieve their assigned UEI (SAM) number. New grantees will be assigned a UEI when they register on SAM.gov. Grantees are encouraged to confirm their EIN and UEI prior to submission of the report and application.

Governor Documentation and Assurances

 - Written on the Governor’s letterhead
 - Designates the lead agency to receive the funds
 - Include a statement: “the [lead agency] was designated only after giving full and equal consideration to the capacity and expertise of all entities desiring to be the lead agency.”
 - Signed by the Governor

Description of the CBCAP Lead Agency's Leadership Role in State Prevention Activities

- This section describes the role of the lead agency and how it will lead the child maltreatment prevention activities in the state, to include:
 - interdisciplinary, collaborative, and public-private structure, including its representation from private and public sector parents and service providers
 - how community-based child abuse and neglect prevention programs and activities will be integrated into a developing continuum

Actions to Advocate for Systemic Change

- A description of the actions that the CBCAP lead agency will take to advocate systemic changes in state policies, practices, procedures and regulations to improve the delivery of community-based child abuse and neglect prevention programs and activities.
- Explain how the states plans to continue or to begin conducting prevention planning efforts and how these efforts will be integrated with other strategic planning efforts in child welfare, early childhood, or other related systems.

- The report should include information about strength of the collaborations and coordination efforts, the nature and quality of those relationships and what other impacts these connections and partnerships have made.

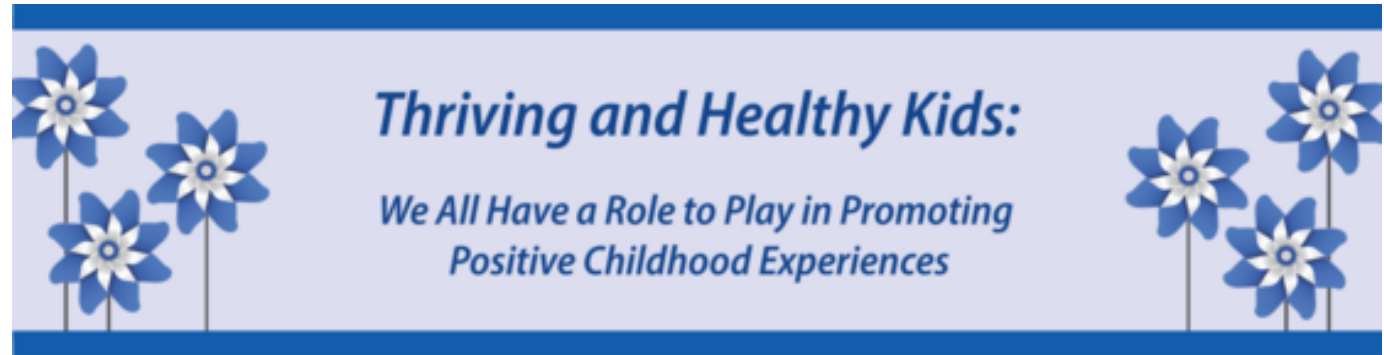
