

## The History of HOPE

CBCAP requires us to support programs and activities that maximize the participation of racial and ethnic minorities and members of other underserved or underrepresented groups. My predecessor began working to increase Georgia's intentional partnerships with communitybased organizations that primarily serve communities of color and underserved groups... and HOPE was born.



#### **Getting Started**

- In March 2022, selected agencies were invited to attend a webinar orientation to discuss the goals of the HOPE initiative and the DFCS contracting process.
- Most of these agencies are small and were not familiar with the requirements of contracting with the state.
- We offered maximum technical assistance and support to provide them with the maximum opportunity for a successful contract execution.
- We also offered the option of a July 1 or October 1 contract start date, depending on how quickly they believed they could submit their required documentation, including a proposal of work and a budget.

## The Proposal Narrative

- Purpose and history of the organization
- Address the community need include relevant statistics/data to support need
- Demographics of population served
- Purpose and information about the program/initiative and how it meets the need
- Goals and objectives
- How the work with families or youth will address at least 1 of the 5 Protective Factors
- Evaluation

#### Tips:

- Include anything that is unique or additive about the organization and the program/initiative
- Include a short description of other services the organization provides



#### 100 Black Men of Atlanta



- Works with young men (16-26) with children, or children on the way
- Offers GED/adult education, counseling, life coaching, workforce development, assistance with legitimacy and father's rights
- Diversion program in partnership with APD

#### Emory School of Medicine, Department of Pediatrics

- Provides access to quality health care to urban based populations
- Received additional DoE dollars from the governor's office to expand school-based health centers
- Created a family centered model to identify and address factors that affect child mental health
- Trains future pediatricians on specific work with underserved communities



## Beginning New Outreach

- Newest HOPE agency (contracted in April)
- Faith based organization that provides food and clothing to underserved, low-income families
- Youth Pillars
  - Preventing teen pregnancy through abstinence
  - Preventing teen drinking and drug use
  - Preventing bullying
  - Increasing college/career readiness



### We Love Buford Highway

- Works with underserved elementary school children (3<sup>rd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> graders) in the immigrant community
- Orchestra that focuses on the whole child
- Promotes family engagement and well-being, builds selfesteem, teamwork, and community



Major difficulties getting an executed contract

We are currently working with and developing 4 new (ish) agencies expected to receive FY24 contracts

- Potential agency #1 (mobile clothing closet)
- Potential agency #2 (substance abuse/sexual offender treatment)
- Potential agency #3 (interview series triumphs and challenges of fatherhood)
- Potential agency #4 (teen mom housing and support)





## Lessons Learned

- Contracting process is very difficult
  - Insurance/Background Checks
  - Internal biases (most people don't understand prevention work)
  - Initial meeting to determine fit
  - Second meeting to review processes
  - Begin paperwork early
- Lots of guidance and information is needed
  - Quarterly cohort meetings to learn from each other
  - Regular and consistent check-ins
