



Welcome to the 2023 CBCAP Annual Grantee Meeting





## What are we seeing regarding change in cohort 2?

- Distinguishing between neglect and poverty; state policy changes
- Going deeper with parent leadership and parent engagement with prevention, preparing to use BEPPC to develop structure and provide training
- Co-designing with parents and piloting new Parent Leadership Evaluation Guidance
- Developing a prevention culture before implementing strategy (Spirit before Action)
- Addressing shared prevention language across continuum with state staff and others
- Warm lines and more family strengthening referral sources
- Hiring a Prevention Mindset Coordinator to support prevention initiatives and improve collaboration
