## Bring Up Nebraska’s Statewide Plan for Community Well-Being

Nebraska will have the most robust Community Well-Being prevention model in the nation by 2025.

### Nebraska's Goals

#### By 2025, we will...

1. Improve authentic collaboration between lived experience partners, system partners, local school districts, and community collaboratives and community members.
2. Increase community collaborative infrastructure that leads to equitable well-being outcomes.
3. Improve services and supports that build Protective and Promotive Factors in children, youth, families, and communities, including:
  1. Education, postsecondary education, and career services and support for children, youth, families, and communities hosted both inside and outside of the traditional school day.
  2. Supports and services for youth/young adults and young parents/families.
  3. Access to and increased capacity of early childhood services in communities.
  4. Access to and increased capacity of physical and behavioral health services in communities.
  5. Access to economic stability and concrete support for children, youth, families, and communities.
4. Strengthen the well-being workforce in Nebraska.

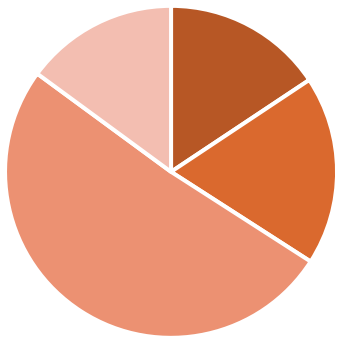

# Bring Up Nebraska

## FUTURE PLANS & OPPORTUNITIES:

- **Nebraska DHHS – Families First Prevention Services Act**

- Proposed Updates to candidacy
- Proposed utilization of Motivational Interviewing for Central Navigation
- Partnerships with Dept of Public Health to expand home visiting
- Central Access/warm-line for prevention

- **Maternal, Infant, and Early Childhood Home Visiting (MIECHV) and Other Home Visitation Funds (State)**

- Increasing in funding for evidence-based home visiting
- New funding allotment for evidence based universal home visiting
- Additional funding through match amounts through MIECHV

- **Nebraska DHHS – Division of Behavioral Health**

- Behavioral Health funding and supports for non-clinical behavioral health needs/prevention
- Partnerships between Behavioral Health and Dept of Education/local schools for school-based behavioral health supports and navigation

- **Medicaid Priorities – Social Determinants of Health**

- Medicaid coding for prevention services categorized as SDOH
- Medicaid funding for Central Navigation in clinical settings
